**CONSENT ORDER**

Commissioner of Commerce Glenn Wilson (hereinafter "Commissioner") has determined as follows:

1. The Commissioner has advised Bart W. Murnion that he is prepared to commence formal action pursuant to Minn. Stat. § 45.027 (2002), and other applicable law, against Respondent's insurance agent license based on the Montana Consent Order dated June 15, 2006; the Montana Order for Temporary Cease and Desist dated May 9, 2006; based on allegations that Respondent failed to notify our Department of the two Orders; and failed to notify our Department of the Bankruptcy filing dated June of 2004, in violation of Minn. Stat. § 60K.43, subd.1 (9); Minn. Stat. § 60K.54; and Minn. Stat. § 60K.43, subd.1(1).

2. Respondent acknowledges that he has been advised of his rights to a hearing in this matter, to present argument to the Commissioner and to appeal from any adverse determination after a hearing, and Respondent hereby expressly waives those rights. Respondent further acknowledges that he has been represented by legal counsel throughout these proceedings, or has been advised of his right to be represented by legal counsel, which right he hereby waives. Respondent neither admits nor denies the allegations set forth in this Order.

3. Respondent has agreed to informal disposition of this matter without a hearing as provided under Minn. Stat. § 14.59 (2000) and Minn. R. 1400.5900 (1999).

4. The following Order is in the public interest.

**NOW, THEREFORE, IT IS HEREBY ORDERED**, that Respondent's insurance agents license is revoked.

This Order shall be effective upon signature on behalf of the Commissioner.


