CONSENT ORDER

In the Matter of the Real Estate License of Douglas R. Brown License No. 20368333; and Sure Foundation Real Estate, LLC, License No. 20368332.

Commissioner of Commerce Glenn Wilson (hereinafter "Commissioner") has determined as follows:

- 1. The Commissioner has advised Douglas R. Brown (hereinafter "Respondent") that he is prepared to commence formal action pursuant to Minn. Stats. §§ 45.027 and 82.27 (2004), against Respondent's real estate broker license and the corporate real estate license of Sure Foundation Real Estate, LLC based on allegations that Respondent, while acting under the authorities of his real estate and building contractor licenses entered into a transaction with Paul and Marty Stariha and has engaged in acts or practices which demonstrate that he is untrustworthy, financially irresponsible or otherwise incompetent or unqualified to act under the authorities of the licenses granted by the commissioner in violation of Minn. Stat. § 45.027, Subd. 7 (4) (2004).
- 2. Respondent acknowledges that he has been advised of his rights to a hearing in this matter, to present argument to the Commissioner and to appeal from any adverse determination after a hearing, and Respondent hereby expressly waives those rights. Respondent

further acknowledges that he has been represented by legal counsel throughout these proceedings, or has been advised of his right to be represented by legal counsel, which right he hereby waives.

- 3. Respondent has agreed to informal disposition of this matter without a hearing as provided under Minn. Stat. § 14.59 (2004) and Minn. R. 1400.5900 (2003).
 - 4. The following Order is in the public interest.

NOW, THEREFORE, IT IS HEREBY ORDERED, that the real estate broker license of Douglas R. Brown is SUSPENDED from the date of the signing of this order until June 30, 2006.

IT IS FURTHER ORDERED, that the real estate corporate license of Sure Foundation Real Estate, LLC is SUSPENDED from the date of the signing of this order until June 30, 2006.

This Order shall be effective upon signature by or on behalf of the Commissioner.
