CONSENT ORDER

Commissioner of Commerce Glenn Wilson (hereinafter "Commissioner") has determined as follows:

1. The Commissioner has advised Patrick James O'Meara (hereinafter "Respondent") that he is prepared to commence formal action pursuant to Minn. Stat. § 45.027 (2004), and other applicable law, against Respondent's securities and insurance producer's licenses based on allegations that Respondent violated Minn. Stat. §60K.43 subd. 1 (8) (2004) by demonstrating fraudulent, coercive or dishonest practices or demonstrating incompetence, untrustworthiness or financial irresponsibility as an insurance producer..

2. Respondent acknowledges that he has been advised of his rights to a hearing in this matter, to present argument to the Commissioner and to appeal from any adverse determination after a hearing, and Respondent hereby expressly waives those rights. Respondent further acknowledges that he has been represented by legal counsel throughout these

proceedings, or has been advised of his right to be represented by legal counsel, which right he hereby waives.

3. Respondent has agreed to informal disposition of this matter without a hearing as provided under Minn. Stat. § 14.59 (2004) and Minn. R. 1400.5900 (2003).

4. The following Order is in the public interest.

NOW, THEREFORE, IT IS HEREBY ORDERED, that the securities and insurance producers licenses of Respondent Patrick James O'Meara are revoked.

This Order shall be effective upon signature on behalf of the Commissioner.



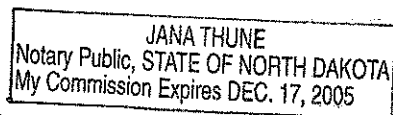


