NOW, THEREFORE, IT IS HEREBY ORDERED, that pursuant to Minn. Stat. § 45.027 Subd. 7 (2004) Respondent complete 30 hours of qualified appraiser training and provide evidence satisfactory to the Commissioner of having completed said hours on or before April 7, 2006.

IT IS FURTHER ORDERED that pursuant to Minn. Stat. § 45.027, subd. 6 (2004), as amended, Respondent shall pay to the State of Minnesota a civil penalty of \$1,000.
