Respondent further acknowledges that he has been represented by legal counsel throughout these proceedings, or has been advised of his right to be represented by legal counsel, which right he hereby waives.
- 3. Respondent has agreed to informal disposition of this matter without a hearing as provided under Minn. Stat. § 14.59 (2004) and Minn. R. 1400.5900 (2003).

4. The following Order is in the public interest.

NOW, THEREFORE, IT IS HEREBY ORDERED, that pursuant to Minn. Stat. § 45.027 Subd. 7 (2004) Terry Arthur Thompson is censured.

IT IS FURTHER ORDERED that Respondent complete 7.5 hours of qualified appraiser training and provide evidence satisfactory to the Commissioner of having completed said hours on or before June 16, 2006.
