CONSENT ORDER

Commissioner of Commerce Glenn Wilson has determined as follows:

1. The Commissioner has commenced formal administrative action against the debt collector registration license of Biviana Edith Cuello-Rodriguez a/k/a Araceli Olivarez.

2. Respondent acknowledges that she has been advised of her right to a hearing in this matter, to present argument to the Commissioner and to appeal from any adverse determination at a hearing, and Respondent hereby expressly waives those rights. Respondent further acknowledges that she has been represented by legal counsel throughout these proceedings, or has been advised of her right to be represented by legal counsel, which right she hereby waives.

3. Respondent has agreed to informal disposition of this matter without a hearing as provided under Minn. Stat. § 14.59 (2004) and Minn. R. 1400.5900 (2005).

4. The following Order is in the public interest.

NOW, THEREFORE, IT IS ORDERED that debt collector registration license of Respondent Biviana Edith Cuello-Rodriguez a/k/a Araceli Olivarez is hereby **REVOKED**.

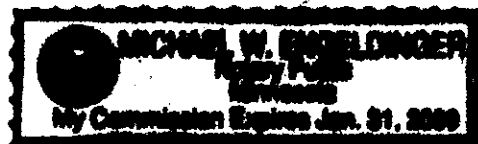
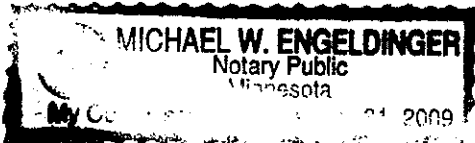


